

## **Bank Asya's Consolidated Net Profit For 6 Months is TL 145 Million**

Bank Asya's consolidated net profit for the first 6 months of 2009 has increased 46 % compared to the same fiscal period of previous year and reached TL 145 million.

Consolidated Financial Statement of Asya Katılım Bankası A.Ş. dated June 30 2009 was published on August 27<sup>th</sup>, 2009 in "Public Disclosure Platform" and "Istanbul Stock Exchange".

The written statement published by Bank Asya includes the Bank's consolidated figures for the first six months of 2009. The net profit of Bank Asya which was TL 99 million for the first six months of 2008 has increased to TL 145 million growing 46% in the same fiscal period of 2009. The shareholder's equity has increased to TL 1.564 million growing 11%, total assets have increased to TL 9.876 million growing 21% and funds collected via current and savings accounts have increased to TL 7.366 million growing 27% compared to the end of the year. On the other hand, total cash loans have accrued TL 7.043 million and total non-cash loans have accrued TL 9.452 million.

In the written statement it was stated that Bank Asya, which makes remarkable achievements in spite of being the youngest finance house of Turkey, will maintain its success and work to expand its operations profitably and reliably without disregarding circumspection required by the conditions of financial crisis. It was also underlined that this expansion can only be provided by concern, trust and support of its customers and announced that Bank Asya aiming at expanding its branch network was authorized to open 6 new branches by BRSA and the branches will open within a short space of time.
